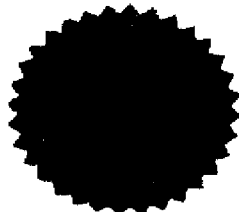

FIRST, that the Board of Directors of FITEL USA CORP., by a written consent of the sole stockholder, filed with the minutes of the board, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

RESOLVED, that the Certificate of Incorporation of FITEL USA CORP. be amended by striking Article 1 in its entirety and replacing therefor:

ARTICLE I

The name of the corporation (which is hereinafter referred to as the "Corporation") is:
