for which application is being made for Letters Patent, said application being executed by me on the date of January 14, 2009, and further being identified by Attorney's Docket 057190.000013.



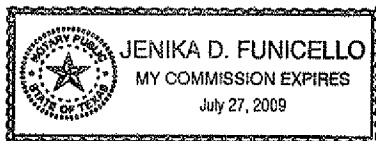


