All of the above-mentioned rights, titles, and interests are to be held and enjoyed by the Assignee, for its own use and behalf and the use and behalf of its successors, legal representatives, and assigns, to the full end of the term or terms for which Letters Patent or Patents may be granted as fully and entirely as the same would have been held and enjoyed by the Assignor had this sale, assignment, transfer, and set over not been made;


Assignor, any and all benefits, including the right of priority provided by any and all treaties, conventions, or agreements;
