ASSIGNMENT OF PATENT APPLICATION

WHEREAS, WE, Alexander YPMA, Aalbert de VRIES, Joseph Renier Gerardus Maria LEENEN, and Job GEURTS citizens of Netherlands (hereinafter referred to as "ASSIGNORS"), have invented a certain invention entitled **ASYMMETRIC ADJUSTMENT** for which Utility Application for Letters Patent of the United States of America has been filed on November 4, 2008 and given application number 12/264,546, and

equivalent thereof, to issue said patents to ASSIGNEE, its successors and assigns, in accordance with this Assignment.

ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;




