incurred by said Inventors in providing such cooperation shall be paid for by said Genencor International, Inc.

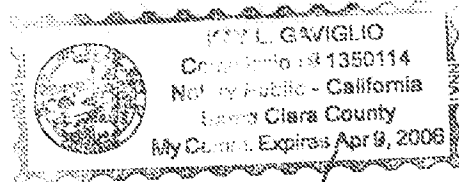

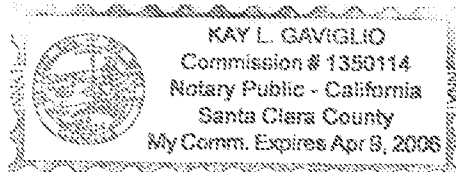

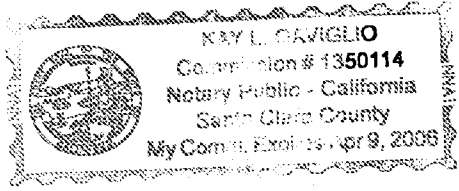
