INVENTOR further agrees to communicate to **TID** or to its successors, assigns and legal representatives, any facts known to **INVENTOR** respecting the said invention, and at the expense of **TID**, sign any and all patent applications, assignments, affidavits and other lawful papers, execute all divisional, continuation, reissue and substitute applications, make all lawful oaths, testify in any legal or quasi-legal proceedings and generally do everything possible to aid said **TID**, its successors, assigns and nominees to obtain and enforce proper patent protection for said invention in all countries outside Germany.




