ASSIGNMENT OF UNITED STATES PATENT APPLICATION



Further, I agree that I will communicate to said Teradata US, Inc, or its representatives, any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitution, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Teradata US, Inc, make all rightful oaths and generally to do everything possible to aid said Teradata US, Inc, its successors and assigns, to obtain and enforce protection for said invention in the United States and in any and all foreign countries.
