And we do hereby authorize and request the Commissioner of Patents and Trademarks to issue any Letters Patent which may be granted for or upon said invention or applications unto the said CONEXANT SYSTEMS, INC., its successors and assigns, in accordance with this assignment.

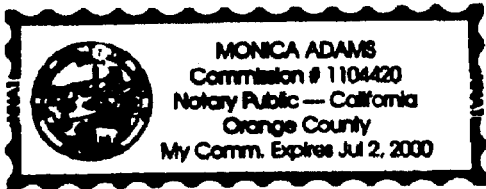
