ASSIGNMENT OF PATENT MATTERS

WHEREAS, **Sprint Spectrum L.P.**, a corporation duly organized under and pursuant to the laws of Delaware, and having its principal place of business at 6450 Sprint Parkway, Overland Park, Kansas 66251-2100, hereinafter referred to as "Assignor," is the owner of the entire right, title, and interest in and to the invention disclosures, patent applications, and patents (including the underlying inventions of said applications and patents) ("Patent Matters") as identified in the attached Schedule of Patent Matters (listing of pending patent applications and issued patents only).

WHEREAS, Sprint Nextel Corporation, the parent company of Assignor, entered into a Transaction Agreement and Plan of Merger (TAPM) with Clearwire Corporation and pursuant to the TAPM, Sprint Nextel Corporation and Clearwire Communications LLC, a wholly-owned subsidiary of Clearwire Corporation, entered into an Intellectual Property Agreement dated November 28, 2008 in which Sprint Nextel Corporation agreed, among other things, to assign the Patent Matters to Assignee, as designated by Clearwire Communications LLC.

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN: Be it known that, for good and valuable consideration, receipt of which is hereby acknowledged by Assignor, Assignor has sold, assigned, transferred, and set over, and does sell, assign, transfer, and set over unto the Assignee, and Assignees' successors, legal representatives, and assigns, the entire right, title and interest in and to said Patent Matters, including any provisional and non-provisional applications, both United States and foreign, which the undersigned may file, either solely or jointly with others directed to the Patent Matters, and in and to any and all Letters Patent of the United States and foreign countries, which may be obtained on any of said Patent Matters, including any of said provisional and non-provisional applications, and in and to any and all further applications claiming priority to said Patent Matters and said provisional and non-provisional applications, including divisions, renewals, substitutions, conversions, continuations, and continuations-in-part, and reissues and prolongations and extensions, and further assigns to said Assignee the priority right provided by the International Convention, together with all rights to sue and recover for past infringement thereof, to have and to hold forever for the sole and exclusive use and benefit of Assignee, its successors, legal representatives, and assigns,

AND Assignor hereby represents, warrants, and covenants that Assignor has the full right to convey the interest assigned by this Assignment, and Assignor has not executed and will not execute any agreement in conflict with this Assignment,

AND for the same consideration, the Assignor hereby represents, warrants, covenants and agrees to and with the Assignee, its successors, legal representatives, and assigns, that the Assignor will (whenever counsel of the Assignee, or the counsel of its successors, legal representatives, and assigns, shall advise of any proceeding or needed act in connection with said

invention or said applications for Letters Patent or Patents, or of any proceeding or needed act in connection with Letters Patent or Patents for said inventions in any country, including interference proceedings, or similarly in regard of any application claiming priority to said application, division, continuation, or continuation-in-part of any applications for Letters Patent or Patents, or any reissue or extension of any Letters Patent or Patents to be obtained thereon), sign all papers and documents, and take all lawful oaths without charge to the Assignee (and its successors, legal representatives, and assigns) for the procurement of Letters Patent or Patents for said inventions, and further, in regard of enforcement and defense of Letters Patent or Patents for said inventions, Assignor agrees to provide commercially reasonable cooperation but at cost to Assignee (or its successors, legal representatives, and assigns);

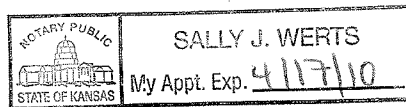
