ASSIGNMENT OF PATENT RIGHTS

For good and valuable consideration, the receipt of which is hereby acknowledged, Intel Corporation, a Delaware corporation (the "Assignor") does hereby sell, assign, transfer and convey unto RadiSys Corporation, an Oregon corporation ("Assignee") all of Assignor's right, title and interest in and to the patents (the "Patent Rights") listed on the attached Exhibit 1 (the "Transferred Patents"), subject to any licenses retained by or granted to Assignor pursuant to the accompanying Asset Purchase Agreement and Acquisition Documents (as defined therein), and subject to licenses existing as of the date hereof, and Assignee desires to acquire such entire right, title and interest in and to the Patent Rights, including any patents issuing from or based upon all patent applications thereon, or any continuations, continuations-in-part, divisions, reissues, re-examinations or extensions of the Patent Rights, to the full end of the term for which patents are granted, as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made, subject to such licenses.

Assignor agrees to and hereby does sell, assign, transfer, and convey unto Assignee all rights: (i) in and to causes of action and enforcement rights for the Patent Rights including rights to pursue damages, injunctive relief and other remedies for past and future infringement thereof, and (ii) to apply in any or all countries of the world for patents, certificates of invention or other governmental grants for the Patent Rights, including without limitation under the Paris Convention for the Protection of Industrial Property, the International Patent Cooperation Treaty, or any other convention, treaty, agreement, or understanding. Assignor also authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents or certificates of invention which may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein.
