ASSIGNMENT OF PATENT RIGHTS

The undersigned assignors, Maria Lantin, residing in Vancouver, Canada, David J.P. - United States patent application number 10/619,555 (filed July 16, 2003) and all divisions, continuations (in whole or in part), substitutions, renewal, or other applications claiming priority rights from the Patents and/or any such applications (the "*Applications*");
- All letters patents, United States patents or other governmental grants or issuances that may be granted or issued with respect to the Inventions (the "*Patents*");
- All reissues, requests for continuing examinations, reexaminations, extensions or registrations of the Applications and/or the Patents;
- All non-United States patents, patent applications, and counterparts with respect of the Inventions, the Applications, and the Patents including, without limitation, certificates of invention, utility models, industrial design protection, design patent protection, and other governmental grants or issuances, and including the right to file foreign applications directly in the name of Assignee;
- The right to claim priority rights deriving from the Patents and/or Applications and for Assignee to otherwise avail itself of the provisions of the international conventions governing the protection of inventions;
- To the extent permissible under applicable laws, all causes of action, remedies and other enforcement rights related to the Applications, the Inventions, and the Patents (including, without limitation, the right to sue for past, present or future infringement, misappropriation or violation of rights related to the Applications, the Inventions, and the Patents);
- All rights to collect royalties and other payments under or on account of any of the Applications, the Inventions, and the Patents; and
- Any and all other rights and interests arising out of, in connection with, or in relation to the Applications, the Inventions, and the Patents.

Assignor agrees to do all such lawful acts and things and to execute without further consideration such further lawful assignments, instruments, assurances, applications and other documents as may reasonably be required by Assignee to obtain any and all letters patent for the inventions and vest or secure the same in Assignee.


Assignors request the respective patent office or governmental agency in each jurisdiction to grant or issue any and all letters patents, certificates of invention, utility models or other governmental grants or


