**ASSIGNMENT**

WHEREAS I,

**Sander TEUNISSEN**, (the "Inventor"), residing at **Burg. FURTHER I hereby authorize and request any official of any state, responsible for issuing patents or other evidence or forms of any industrial property protection, to issue the same for the invention to the Company, its successors, legal representatives and assigns, in accordance with this assignment.


