All of the Assets described on Exhibit "B" attached hereto ("Assets").



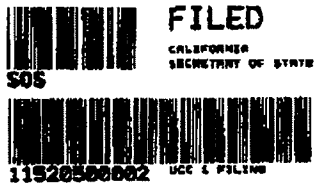
