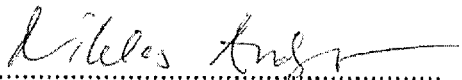

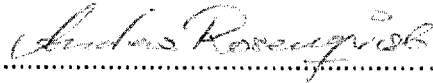

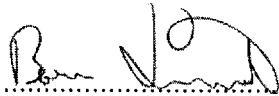

country of the inventor's residence. The language to be used in the arbitral proceedings shall be English.

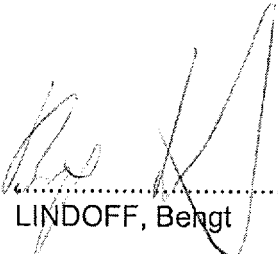

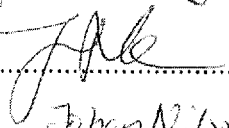

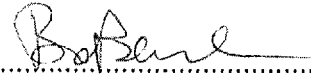
