ASSIGNMENT

We hereby warrant that we have the full right to make the conveyance herein, and we hereby covenant that we, and our heirs, legal representatives, and assigns, will, when requested, communicate to said Company, its representatives, successors, and assigns, all facts known respecting said inventions, execute all divisional, continuing, reissue, reexamination, and foreign or international applications, together with individual assignments therefor, make all rightful oaths, sign all lawful papers, testify in any legal proceeding, and generally do everything possible to aid said Company, its successors, and assigns, in the obtaining of Letters Patent.
