## ASSIGNMENT

THIS ASSIGNMENT is made on the 30<sup>th</sup> day of *January* Two thousand and eight, *1998*

### BETWEEN

- (1) Femcare (Cyprus) Limited, of Meliza Court, 4<sup>th</sup> & 7<sup>th</sup> Floors, 229 Archbishop Makarios III, Avenue Limassol, Cyprus (hereinafter called "the Assignor") of the one part; and
- (2) Femcare Limited, Stuart Court, Spursholt Place, Salisbury Road, Romsey, Hampshire, SO51 6DJ (hereinafter called "the Assignee") of the other part.

### WHEREAS:

- (A) The Assignor is the registered proprietor and beneficial owner of the patents and patent applications set out in the appended schedule (hereinafter referred to as "the Patents and Patent Applications").
- (B) The parties hereto have agreed that the Assignor's rights in the Patents and Patent Applications should be transferred by the Assignor to the Assignee for the consideration hereinafter set forth.

### NOW IT IS HEREBY AGREED

1. In consideration of the sum of £1.00 now paid by the Assignee to the Assignor (the receipt whereof is hereby acknowledged) and Assignor HEREBY ASSIGNS with full title guarantee absolutely and free from any licences, charges or other encumbrances:-
  - 1.1 All right, title and interest in and to the Patents and the Patent Applications (including any and all divisions, reissues, continuations and extensions thereof) to the intent that grant of any patents thereon shall be in the name of and shall vest in the Assignee TOGETHER WITH all rights and powers arising or accruing therefrom including the right to sue for damages and other remedies in respect of any infringement of such rights or other acts within the scope of the claims of any published specification of the Patents and Patent Applications prior to the date hereof; and
  - 1.2 The right to apply for, prosecute and obtain patent or similar protection throughout the world in respect of any invention claimed in the Patents and Patent Applications including the right to claim priority therefrom to the intent that the grant of any patents or similar protection shall be in the name of and vest in the Assignee.

2. The Assignor agrees that at the request of the Assignee it will at all times hereafter do all such acts and execute all such documents (including the making of or deposing to any declaration or oath) as may reasonably be necessary or desirable to secure the vesting in the Assignee of all rights assigned to the Assignee hereunder, to secure registration of this Assignment at the relevant Patent Offices and to assist in the resolution of any question concerning the Patents and Patent Applications.
3. The parties agree that this Assignment shall be governed by and construed in accordance with English law and hereby submit to the non-exclusive jurisdiction of the English Courts.

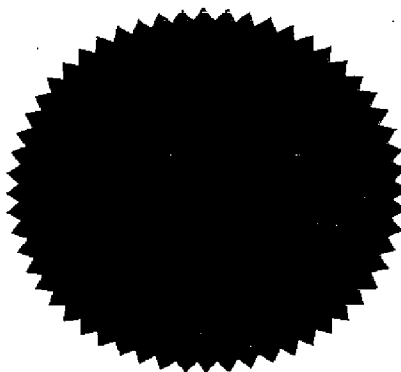
