PATENT ASSIGNMENT AGREEMENT
(USA, Nixon)

This Agreement is effective from the 1st day of April, 2008

Between

- (1) BP CHEMICALS LIMITED, a company incorporated in England with registered number 00194971 whose registered office is at Chertsey Road, Sunbury on Thames, Middlesex, TW16 7BP, UNITED KINGDOM (the "**Assignor**"); and
- (2) INEOS EUROPE LIMITED, a company incorporated in England with registered number 05310655, whose registered office is at Hawkslease, Chapel Lane, Lyndhurst, Hampshire, SO43 7FG, UNITED KINGDOM (the "**Assignee**").

Whereas:

- (A) The Assignor is the owner of the Patent[s].
- (B) The Assignor has agreed to assign the Patent[s] to the Assignee upon the terms set out in this Agreement.

It is agreed as follows:

1 Definitions

In this Agreement, "**Patents**" means the registered patents and patent applications listed in the *Schedule to this Agreement*.

2 Assignment

In consideration of the sum of ten euros (10 euros), receipt of which is acknowledged, the Assignor hereby assigns to the Assignee all of its rights, title and interest in and to the Patents including, without limitation, the right to claim priority under the Paris Convention therefrom and the right to bring proceedings and seek remedies for infringement of the Patents prior to the date hereof, and with the intent that any patent granted pursuant to any application for a Patent shall be granted in the name of and vest absolutely in the Assignee.

3 Further Assurance

The Assignor shall, at its own expense, execute all documents and do all such acts and things as may be reasonably requested by the Assignee in order to give legal effect to the assignment of the Patents to the Assignee.

4 Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with English law and the courts of England shall have jurisdiction over any disputes arising out of or in connection with this Agreement.
