The Assignors hereby authorize and request the Commissioner of Patents and Trademarks of the United States of America and any official of any country or countries foreign to the United States of America whose duty it is to issue patents on applications as aforesaid, to issue any said Letters Patent to the Assignee of the entire right, title and interest in and to the same, for their sole use and benefit, and for the use and benefit of their successors and assigns, to the full end of the term for which the Letters Patent may be granted as fully and entirely as the same would have been held by the Assignors had this assignment and sale not been made.
