ASSIGNMENT

The undersigned inventors, C. David Hale and Alfred P. Horning of the residences indicated below (hereinafter referred to as "Assignors"), have invented a **MOTORIZED DRAIN CLEANING MACHINE** (hereinafter the "Invention"). Authorize and request the Director of the United States Patent & Trademark Office, and such patent office officials in foreign countries as are duly authorized by their laws to issue patents, to issue any patents on the Invention to Assignee as the owner of the entire right, title, and interest therein or otherwise as Assignee may direct;

4. Agree, without expense to Assignors but without further consideration, to carry out in good faith the intent and purpose of this Assignment by executing all divisional, renewal, substitute, continuation, continuation-in-part, reissue, and all other patent applications based on the Invention; executing all rightful oaths, assignments, powers of attorney and other papers; communicating to Assignee all facts known to Assignors relating to the Invention and the history thereof; and generally, doing everything reasonably possible which Assignee shall consider desirable for aiding in securing, maintaining, and enforcing proper protection for the Invention and for vesting title in Assignee to the Invention and all patent applications and patents based on the Invention;

5. Represent and warrant that Assignors have the full right to convey to Assignee the entire interest to the Invention, and that Assignors have not executed, and will not execute, any agreement in conflict herewith;

6. Agree to transfer a like interest upon request of Assignee, and without further remuneration, in and to any improvements growing out of or relating to the Invention or any patent applications or patents based thereon;

7. Authorize Assignee to insert in this Assignment the serial number and filing date of the Applications or any other information which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this Assignment; and

8. Covenant that this Assignment shall be binding upon Assignors' heirs, successors, and legal representatives.

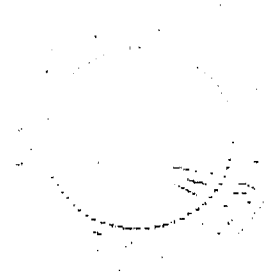
