CONFIRMATORY ASSIGNMENT

This Confirmatory Assignment ("Assignment") shall be effective as of December 19, 2008 ("Effective Date") by and between:

GARY LENNEN, residing at 10375 Rivercrest Ct., Cupertino, CALIFORNIA 95014; ("ASSIGNOR"), and

SiRF Technology, Inc., a corporation of the State of Delaware, having a principal place of business at 217 Devcon Drive, San Jose, CA 95112-4211 ("SiRF").

1.0 Background

1.1 ASSIGNOR, through his/her employment with SiRF, as either employee or contractor, as the case may be, invented certain new and useful improvements as described and set forth in an application for Letters Patent of the United States titled "METHOD AND APPARATUS FOR MITIGATING THE EFFECTS OF CROSS-CORRELATION IN A GPS RECEIVER", U.S. Non-Provisional Patent Application Serial No. 12/340,498 filed December 19, 2008, which claims priority to U.S. Provisional Patent Application Serial No. 61/076,600 filed on June 27, 2008. The subject matter of this patent application shall be referred to as the "Invention."

1.2 SiRF, as employer of ASSIGNOR, owns all right, title and interest in and to the Invention. ASSIGNOR, as consideration for his/her employment with SiRF, agreed to execute all the necessary documents in order to perfect and confirm SiRF's ownership in any inventions created or developed by ASSIGNOR during his/her employment with SiRF.

1.3 For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR is executing this Assignment in order to confirm SiRF's ownership in and to formally transfer to SiRF all right, title and interest in and to the Invention and all Letters Patent which may be granted from the Invention in the United States or any foreign country.

2.0 Assignment

2.1 ASSIGNOR sells, assigns and transfers to SiRF, effective as of the Effective Date first set forth above, the full and exclusive right, title and interest in and to the Invention and all Letters Patent which may be granted from the Invention in the United States, including any continuation, division, renewal, substitute or reissue thereof for the full term or terms for which the patents may be granted.

2.2 ASSIGNOR also assigns all of his/her right, title and interest in and to the Invention in all foreign countries, including the right to apply for a patent in any foreign country and the right to all current and further applications for patents for the Invention, including the right to claim International Convention priority.

2.3 ASSIGNOR further transfers and assigns to SIRF all causes of action, rights, and remedies arising under any such patent or application prior to or after the Effective Date of this Agreement.

2.4 ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale.

2.5 ASSIGNOR further covenants that, upon SIF's request, ASSIGNOR will promptly provide SIF with all pertinent facts and documents relating to the Invention, and patents or patent applications as may be known and accessible to ASSIGNOR and ASSIGNOR will testify as to the same in any interference or litigation related to the Invention or any patent or patent application related thereto and will promptly execute and deliver to SIF or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain and enforce the Invention and any patents or patent application relating to the Invention as may be reasonably necessary or desirable.

The terms, covenants and provisions of this Assignment shall inure to the benefit of SIF, its successors, assigns and other legal representatives, and shall be binding upon ASSIGNOR, his/her heirs, legal representatives and assignees.
