WHEREAS, we, Brian D. Sutterfield, of 102 Belmont Road, Apple Valley, Minnesota 55124, U.S.A. and Bradley T. Atwater, of 7 Copper Crow Bend, Medford, New Jersey 08055 U.S.A., have invented certain new and useful improvements in SYSTEM AND METHOD OF PROTECTING A SYSTEM THAT INCLUDES UNPROTECTED COMPUTER DEVICES, for which an application for Letters Patent of the United States has been filed on December 2, 2008, and which may be identified in the United States Patent Office by Application No. 12/326,246.

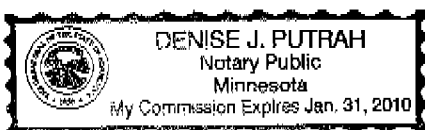



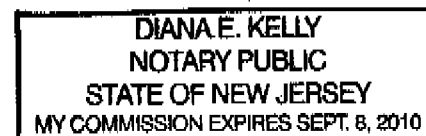
