LIGHT ASSEMBLY FOR AN AUTOMOBILE

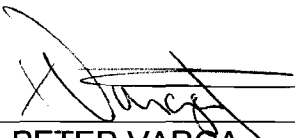
for which an application for Letters Design Patent of the United States of America was executed on the date of execution of this assignment;
