This document was the reason for entry 5 on the same page number B-257554 opened in this Register for the absorbing company, "IQAP MASTERBATCH GROUP, S.L.," entered on page 64 of volume 40141 of the file.

The company "IQAP MASTERBATCH GROUP, S.L." remains in effect in this Register.
