AMENDMENT AND ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Amendment and Assignment of Intellectual Property Security Agreement, dated as of January 15, 2009 (this "Amendment and Assignment"), is made by and among WELLS FARGO FOOTHILL, INC. ("Prior Agent"), PATRIARCH PARTNERS AGENCY SERVICES, LLC, in its capacity as successor Agent under the Credit Agreement ("Agent"), and FINANZ ST. HONORE, B.V., a Netherlands private limited company ("Company").

RECITALS

WHEREAS, certain of Company's affiliates, the Lenders party thereto and Agent (as successor by assignment to Prior Agent) entered into that certain Credit Agreement dated as of June 28, 2007 (as the same has been and may hereafter be amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "Credit Agreement");

WHEREAS, Company and Agent (as successor by assignment to Prior Agent) entered into that certain Intellectual Property Security Agreement (as the same may be amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the "IP Security Agreement") dated as of August 2, 2007;

WHEREAS, pursuant to the IP Security Agreement, Company granted to Prior Agent, as agent on behalf of the Lenders, a continuing security interest in, among other things, all of Company's right, title and interest in and to the Copyrights referred to in Exhibit A hereto, the Patents referred to in Exhibit B hereto and the Trademarks referred to in Exhibit C hereto;

WHEREAS, pursuant to that certain Assignment and Acceptance Agreement dated as of December 31, 2008, by and between, among others, Prior Agent and Agent (the "Assignment Agreement"), Prior Agent resigned as agent for the Lenders under the Credit Agreement and Agent assumed its rights, remedies, duties and obligations as agent for the Lenders under the Credit Agreement, the IP Security Agreement and all other financing and collateral documents executed in connection therewith;

WHEREAS, the parties hereto desire to execute this Amendment and Assignment for the purposes of (i) amending the IP Security Agreement in certain respects to reflect the transfer of Prior Agent's interest as agent for the Lenders to Agent, and (ii) evidencing in the United States Patent and Trademark Office and the United States Copyright Office the assignment by Prior Agent to Agent of all of Prior Agent's rights, remedies, duties and obligations under the IP Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, Company, Agent and Prior Agent hereby agree as follows:

1. Definitions. All capitalized terms used but not defined herein shall have the respective meanings ascribed to such terms in the Credit Agreement.
2. Amendment of IP Security Agreement. Agent and Company hereby agree that the IP Security Agreement shall be amended such that Agent shall replace Prior Agent as

"Agent" thereunder and all references to "Agent" thereunder shall hereinafter refer to Patriarch Partners Agency Services, LLC, as Agent for the Lenders.

3. Assignment. In connection with the assignment from Prior Agent to Agent under the Assignment Agreement, Prior Agent does hereby assign and transfer all of its rights, remedies, duties and obligations as Agent under the IP Security Agreement to Agent, and Agent hereby accepts all of Prior Agent's assignment and transfer of its rights, remedies, duties and obligations as agent for the Lenders under the IP Security Agreement. The execution and delivery of this Amendment and Assignment shall not in any way affect or modify the liability of Company under the IP Security Agreement, it being understood and agreed that notwithstanding this Amendment and Assignment, all of the obligations of Company under the IP Security Agreement shall be and remain enforceable by Agent, as Agent under the IP Security Agreement, or by its successors and assigns against Company.

4. Counterparts. This Amendment and Assignment may be executed in counterparts and by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all of which shall together constitute one and the same instrument. This Amendment and Assignment may be executed and delivered by telecopier or other facsimile transmission or electronic mail all with the same force and effect as if the same were a fully executed and delivered original manual counterpart.

5. Governing Law. THIS AMENDMENT AND ASSIGNMENT SHALL BE GOVERNED BY, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF ILLINOIS.

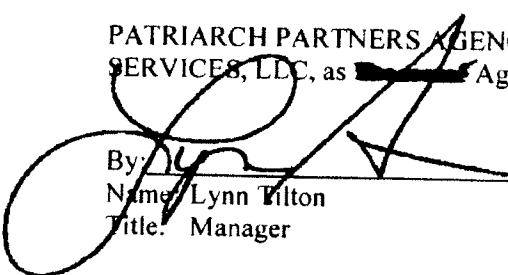

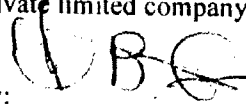
