The Assignor hereby irrevocably undertakes that, at the request of the Assignee the Assignors shall assist the prosecution of the applications to grant patents in connection with the Assigned Patents and Applications and will sign all such documents and do all such acts as may be necessary or proper to obtain the acceptance of the applications and for procuring the grant of a patent pursuant to the Assigned Patents and Applications.

In the event that the validity of the Assigned Patents and Applications and/or any patent granted pursuant thereto is challenged on any point upon which the Assignor has or can procure information or advice which may assist in meeting and defeating or reducing the effect of such challenge, the Assignor agrees and undertakes to supply or procure the supply of such information and/ advice without unreasonable delay.

Assignee grants royalty free licence to Assignor to use the patent outside the Business as defined in the Agreement "Intangible Purchase Agreement" made as of the 15<sup>th</sup> February 2009 by and between Assignee, Assignor, Leortec Ltd. and Oren Aharon Ltd.
