
Utility Models, Copyrights, and legal equivalents thereof to said NIKE USA, its successors or assigns;

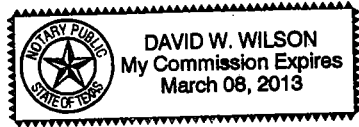
