ASSIGNMENT

WHEREAS, WE, MATHIEU LION, residing at 9 Cite Aubry, 75020 Paris, France and ANNE TANGUY, residing at 184 rue Legendre 75017 PARIS, France, both citizens of France, have invented a new and useful design for TONGS, for which application papers for United States Letters Patent were filed January 16, 2009 and awarded Serial No. 29/331,012, claiming priority to OHIM Design Registration No. 000972922-0001, filed July 18, 2008; and


WHEREAS, MASTRAD, S.A., a corporation organized and existing under and by virtue of the laws of France and having its place of business at 16, rue François Truffaut, Paris, France 75012, is desirous of acquiring the exclusive right, title and interest in and to said invention and in and to the Letters Patent to be granted and issued therefor in the United States of America and its territories and possessions, and all countries foreign thereto:
