
# RECORDABLE PATENT ASSIGNMENT

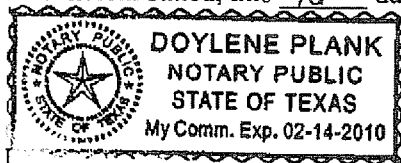


