
RECORDABLE PATENT ASSIGNMENT

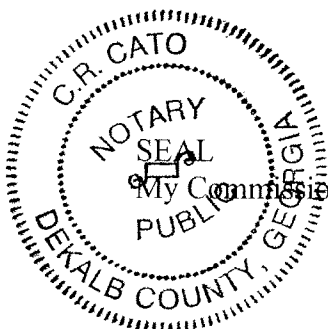
