WHEREAS, pursuant to Section 7(b)(iii) of the Asset Purchase Agreement, Assignor has agreed to deliver this assignment;

WHEREAS, Assignor desires to convey its entire right, title and interest in and to the United States and foreign patents and patent applications set forth in Exhibit A hereto, and any and all inventions disclosed therein ("Patents"); and

WHEREAS, Assignee is desirous of acquiring Assignor's entire right, title and interest in and to the Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the parties hereto, Assignor hereby sells, assigns, conveys and transfers to Assignee, its successors and assigns, Assignor's entire right, title and interest, legal and equitable, in and to the Patents for the United States and its possessions and territories and all foreign countries, including any and all provisionals, divisions, continuations, continuations in part, substitute applications, reexaminations and reissues or extensions thereof; and all resulting patents to the full end of the term for which said Patents may be granted as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made, together with all claims for damages by reason of past infringement of said Patents with the right to sue for and collect the same for its own use and behalf or for the use and behalf of its legal representatives;
