ASSIGNMENT OF INVENTION

WHEREAS, we, Theodor Morel Fishler of 20 Keren Ha'Yesod Street, 34970 Haifa, Israel and David Feldman of 10 Halamish Street, Ramat Almogi, 34997 Haifa, Israel, have invented a certain new and useful improvement Process for the Preparation of Concentrated Solutions of Stabilized Hypobromites (U.S. patent application serial number 12/395,936 on March 2, 2009; and claims priority as a continuation-in-part application of U.S. patent application serial number 12/353,401 filed on January 14, 2009, which is a continuation-in-part application of U.S. patent application serial number 10,513,512 having a 371(c) date of June 20, 2005 (submitted to the USPTO on November 4, 2004); which is a 371 of PCT/IL2003/000363, filed on May 5, 2003; which claims priority to Israeli patent application serial number 149499, filed on May 6, 2002) for which an application for Letters Patent in the United States was executed on the date(s) which appear next to our signatures.

And we hereby authorize and request the Commissioner of Patents and Trademarks to issue said United States Letters Patent to Assignee as the assignee of the whole right, title, and interest thereto.

And we further agree to sign and properly execute such necessary and lawful papers for application for foreign patents, for filing subdivisions of said application for patent, and for obtaining any reissue or reissues of any Letters Patent which may be granted for our aforesaid invention, as the assignee thereof shall hereafter require and prepare at its own expense.
