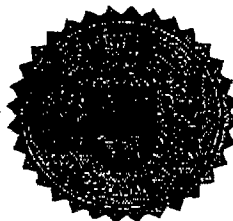

**CERTIFICATE OF AMENDMENT OF  
CERTIFICATE OF INCORPORATION

QUANTIFIED SYSTEMS, INC.**

QUANTIFIED SYSTEMS, INC., a corporation organized and existing under and by virtue of the Delaware General Corporation Law (the "*Corporation*"), DOES HEREBY CERTIFY:

**FIRST:** The Certificate of Incorporation of the Corporation provides that the name of the Corporation shall be "Quantified Systems, Inc."

**SECOND:** Pursuant to the authority expressly conferred upon the Board of Directors and the Stockholders of the Corporation by the Certificate of Incorporation of the Corporation and the Delaware General Corporation Law, said Board of Directors, by written consent dated April 15, 2002, and said Stockholders, by majority vote at the annual meeting of the Corporation held on May 10, 2002, adopted a resolution proposing and declaring advisable an amendment to the Certificate of Incorporation of the Corporation pursuant to which Article I shall be deleted in its entirety and shall be amended to state as follows:

"The name of the Corporation is Urchin Software Corporation  
(hereinafter the "*Corporation*")."

**THIRD:** The Stockholders have approved said amendment to the Certificate of Incorporation of this Corporation at the annual meeting of the Corporation duly called and held in accordance with the provisions of Section 211 of the Delaware General Corporation Law.

**FOURTH:** That said amendment was duly adopted in accordance with the provisions of Section 242 of the Delaware General Corporation Law.
