

- (2) **Sunpower Inc.** a corporation organised under the laws of the State of Ohio and having its principal place of business at 182 Mill Street, Athens, Ohio, 45701-2627 ("Sunpower").

Background

This transfer is entered into pursuant to a Technology Transfer Agreement between BG International Limited and Sunpower Inc. dated 12 July 2007 (the "Technology Agreement").

Transfer

For the consideration specified by, and upon the terms and conditions contained in the Technology Agreement, MEL hereby transfers to Sunpower such rights, title and interest as it may have in the patents and the patent applications (as set out in the tables below) including all rights of priority arising therefrom, together with all rights of MEL to sue for infringement of any of the patents which have accrued prior to the date of this transfer.

Conflict

In the event of a conflict between the provisions of this transfer and the provisions of the Technology Agreement, the latter shall prevail.

Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with English law. Each of the parties irrevocably submits for all purposes in connection with this Agreement to the non-exclusive jurisdiction of the courts of England.
