

ASSIGNMENT AGREEMENT

WHEREAS, We, Csaba Truckai, a United States citizen, residing at 19566 Arden Court, Saratoga, California 95070, Robert Luzzi, a United States citizen, residing at 5759 Athenour Court, Pleasanton, California 94588, Andrew Kohm, a United States citizen, residing at 147 McLellan Ave., San Mateo, CA 94403, and John H. Shadduck, a United States citizen, residing at 1490 Vistazo West, Tiburon, California 94920 ("ASSIGNORS"), have conceived of an invention ("Invention") disclosed in a U.S. Patent Application No. 12/345,937 entitled **BONE TREATMENT SYSTEMS AND METHODS** and filed in the United States Patent and Trademark Office on December 30, 2008, which claims the benefit of U.S. Provisional Patent Application No. 61/009,699 filed December 31, 2007, U.S. Provisional Application No. 61/009,659 filed December 31, 2007, U.S. Provisional Application No. 61/009,671 filed December 31, 2007 and U.S. Provisional Application No. 61/009,673 filed December 31, 2007 (collectively the "Applications");

WHEREAS, DFINE, Inc. (hereinafter "ASSIGNEE"), a Delaware Corporation, with its principal place of business at 3047 Orchard Parkway, San Jose, California 95134 ("ASSIGNEE") desires to acquire the entire right, title, and interest in and to the Invention and the said Applications, as well as all related intellectual property rights as further set forth herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR agrees to assign and does hereby assign to ASSIGNEE the entire right, title, and interest throughout the world in and to each of the following:

B. The Applications, including without limitation any of ASSIGNOR'S inventions that may be disclosed therein; all provisional and non-provisional applications claiming the benefit of the Applications that have been or may hereafter be filed by the ASSIGNEE in the United States or in any foreign country ("Related Applications"); all continuations, divisionals, and continuations in part of the Applications and any such Related Applications; and all U.S. and foreign patents which may be granted on the Applications and the Related Applications, and all reissues, re-examinations, and extensions of such patents;

C. Those items of ASSIGNOR'S tangible property embodying or describing the Invention, including without limitation all documents, drawings, prototypes, models, test results, designs, materials, computer programs and data, and the like, which, if not presently in the possession of ASSIGNEE, will be delivered to ASSIGNEE immediately upon request;

D. All causes of action for infringement of or damage to all rights related to the Invention, the Applications, and/or the Related Applications, whether accruing before or after the execution of this Assignment Agreement, and all legal rights to enforce the same against third parties and to retain the entire proceeds therefrom.

ASSIGNOR AGREES, without further consideration or compensation, to communicate to ASSIGNEE any facts or which ASSIGNOR has knowledge respecting the Invention, Applications, or Related Applications, testify in any legal proceeding, sign all documents, make all rightful oaths and declarations, and generally do everything possible to aid ASSIGNEE in obtaining and enforcing patents for the Invention in all countries. ASSIGNEE agrees to reimburse ASSIGNOR'S reasonable expenses in carrying out his/her obligations under the Assignment Agreement, but only upon ASSIGNEE'S prior written approval of such expenses which in no event shall include ASSIGNOR'S time or legal expense. ASSIGNOR does also hereby authorize and request the Commissioner for Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents on
