ASSIGNMENT

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and in furtherance of the Asset Purchase Agreement dated as of April 4, 2007 (the "APA") among Oasis Industries, Inc. of the foregoing (collectively "Patents") and (c) the right to sue for past, present and future infringements of the Patents and Trademarks and to collect damages therefore.

Industries agrees to execute and deliver to Oasis any and all lawful documents useful or necessary to vest in Oasis complete title, in recordable form, to all of the Patents and Trademarks.

This assignment shall be effective nunc pro tunc as of September 30, 2007.
