

ASSIGNOR also hereby conveys and assigns to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive rights, title and interest to the invention disclosed in said application throughout the world, including the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries, and all rights to enforce said rights against others and recover damages for infringement thereof at any time; and ASSIGNOR further agrees to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.



ASSIGNOR further represents that ASSIGNOR owns the rights being conveyed by this Assignment and have not previously encumbered or assigned to any person or entity other than ASSIGNEE any right that is being assigned to ASSIGNEE herein.
