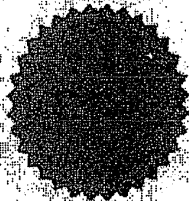

DOES HEREBY CERTIFY:



RESOLVED, that the Certificate of Incorporation of Siemens Westinghouse Power Corporation be amended by changing the name of the Corporation from Siemens Westinghouse Power Corporation to Siemens Power Generation, Inc.
