 - (c) **THE RIGHTS, power, liberties and immunities** arising or to arise therefrom worldwide


TO HOLD unto the **ASSIGNEE** absolutely.


(3) All fees, cost and expenses connected with obtaining the grant of the said Letters Patent worldwide shall be borne and paid by the Assignee.


