4. United States of America utility patent application on the INVENTION, filed as U.S. Patent Application No. 12/377,817 on 17 February 2009 (Attorney's File No. 1600-17700) and entitled "**WELLHEAD ASSEMBLY**," based on and claiming priority to the PCT Application No. PCT/GB2007/003149 filed on 17 August 2007 and the UK Patent Application No. GB 0616423.0 filed on 18 August 2006;

Further, ASSIGNOR warrants that the INVENTION is not encumbered by another assignment or obligation of assignment to a third-party and that ASSIGNOR has the full ability and authority to assign and encumber the INVENTION.


