

ASSIGNMENT

THIS ASSIGNMENT WITNESSETH, That WHEREAS, we, David K. Njaastad, residing at 460 S. We covenant and warrant that we have not executed and will not execute any instrument purporting to convey, mortgage, lease, or otherwise transfer all or any part of said interest to anyone other than the said ASSIGNEE, its successors, legal representatives and assigns.

For the above recited considerations, we, the said ASSIGNORS, hereby covenant and agree for ourselves and for our heirs, executors and administrators that we will, at the request and expense of the said ASSIGNEE, its successors, legal representatives and assigns, execute and deliver, without further consideration, any and all applications, assignments and documents, and perform such other acts as we lawfully may, that may be deemed necessary by the said ASSIGNEE, its successors, legal representatives and assigns, fully to secure its interest as aforesaid and to obtain or maintain Letters Patent in any and all countries.

We hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent which may be granted upon any of the aforesaid applications to the said ASSIGNEE, as the assignee of the entire interest therein.
