A BRAKE SYSTEM AND METHOD

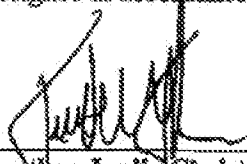

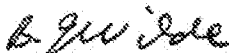

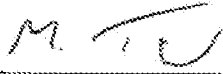
