ASSIGNMENT OF RIGHTS

WHEREAS, Jacqueline A. Zutler, a citizen of the United States of America, residing at 9 Randy Lane, Plainview, New York 11803; and Nancy Cho Ahn, a citizen of the United States of America, residing at 72 Gough Street Apt #20, San Francisco, California 94102; (the ASSIGNORS), have invented certain new and useful improvements disclosed in the United States Design Patent Application entitled "Package for Linens" and filed herewith (the INVENTION); and

ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale.

ASSIGNORS further covenant that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said applications, said inventions and said Letters Patent as may be known and accessible to ASSIGNORS, and ASSIGNORS will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for or obtain, maintain and enforce said applications, said inventions and said Letters Patent which may be necessary or desirable to carry out the purposes hereof.


