**PATENT ASSIGNMENT**

WHEREAS, Chieh Chi CHEN, an individual and citizen of Taiwan, R.O.C., and residing at 4F., No.6, Lane 14, Jingming St., Wunshan District, Taipei City 116, Taiwan, R.O.C. and Sheng-De WANG, an individual and citizen of Taiwan, R.O.C., and residing at 2F., No.6, Lane 18, Wunzhou St., Da-an District, Taipei City 106, Taiwan, R.O.C. (hereinafter ASSIGNORS) have invented certain new and useful improvements relating to a CONTENT ADDRESSABLE MEMORY; and

ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment;

ASSIGNORS further covenant that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said inventions and said Letters Patents and legal equivalents as may be known and accessible to ASSIGNORS and will testify as to the same in any interference, litigation or proceeding related thereto and will promptly execute and deliver to ASSIGNEE or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said invention and said Letters Patent and said equivalents thereof which may be necessary or desirable to carry out the purposes thereof;

For said consideration we hereby covenant and agree that we are the owner of the full undivided interest herein assigned and have the right to assign the same, and agree that we will communicate to ASSIGNEE or its representatives, any facts known to us with respect to said invention or inventions and testify in any legal proceedings relating thereto when called upon, and will sign all instruments and documents and render such assistance which in the judgment of ASSIGNORS is necessary to vest in it and protect the legal title sought to be assigned.
