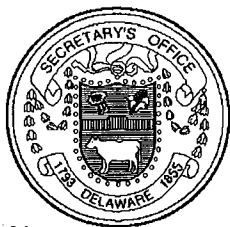



Pursuant to Section 242 of the General Corporation Law  
of the State of Delaware

Renewable Energy Development, Inc. (the "Corporation"), a corporation organized and existing under the General Corporation Law of the State of Delaware (the "DGCL"), DOES HEREBY CERTIFY:

FIRST: The Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on May 29, 2008 under the name Renewable Energy Development, Inc.


SECOND: The following amendment to the Amended and Restated Certificate of Incorporation has been duly adopted in accordance with the provisions of Sections 141, 228, and 242 of the DGCL.

Article FIRST of the Certificate of Incorporation is hereby deleted in its entirety and amended to read as follows:

"FIRST: The name of this corporation is Ioxus, Inc. (the "Corporation")."
