WHEREAS, on or about November 10, 2005, Timothy S. O'Brien and Steve S. Dingle did sell, assign, and transfer to Bou-Matic Technologies LLC, and its legal representatives, successors, and assigns, their entire right, title, and interest in and to their invention ("Invention") described and claimed in United States Patent Application Serial No. 11/280,054 filed on November 16, 2005 at the United States Patent and Trademark Office, now U.S. Patent No. 7,246,503 issued on July 24, 2007, and to all United States and foreign patent applications any of whose claims cover all or part of the Invention, to any prior or provisional application, including any application from which priority is claimed, together with all patents resulting from such applications including any continuations, divisions, reissues, re-examinations and extensions thereof and any applications claiming priority therefrom as recorded on January 16, 2006 at the United States Patent and Trademark Office at Reel 017018, Frame 0456.

WHEREAS, the listed assignee, Bou-Matic Technologies LLC, was misnamed in the prior assignment, which should have designated Bou-Matic Technologies Corporation, a Nevada corporation, as assignee.

WHEREAS, on or about November 5, 2008, Bou-Matic Technologies Corporation effected a name change to Technologies Holdings Corp.

For good and valuable consideration, Timothy S. O'Brien and Steve S. Dingle hereby nunc pro tunc, effective November 10, 2005, sell, assign, and transfer to Technologies Holdings Corp., formerly Bou-Matic Technologies Corporation ("**Assignee**"), a corporation organized under the laws of the State of Nevada, and to its legal representatives, successors, and assigns, their entire right, title, and interest in and to the Invention and to all United States and foreign patent applications any of whose claims cover all or part of the Invention, to any prior or provisional application, including any application from which priority is claimed, together with all patents resulting from such applications including any continuations, divisions, reissues, re-examinations and extensions thereof and any applications claiming priority therefrom. Assignee shall hold such right, title, and interest, nunc pro tunc (effective November 10, 2005) as fully and completely as such right, title and interest would have been held by the Inventors had this assignment and sale not been made.

We agree, upon Assignee's request, to execute or assent to such United States and foreign patent applications and to execute all separate assignments and other legal documents that Assignee may find necessary or desirable in its exercise of the right, title, and interest assigned above. We also agree to communicate to Assignee any facts relating to the Invention or to any of the patent applications or patents contemplated above that may be useful to Assignee and to testify as to such facts in any interferences or in litigation, if requested to do so. We shall do all these things without additional compensation but at no expense to us.

We hereby request the Commissioner of Patents to issue to Assignee, as the owner of the Inventor's

entire right, title, and interest therein, any Letters Patent of the United States that may be issued for the Invention.

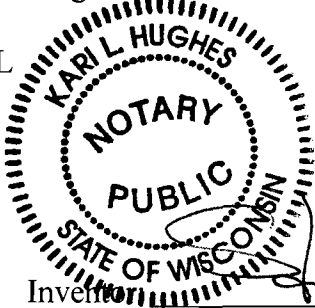

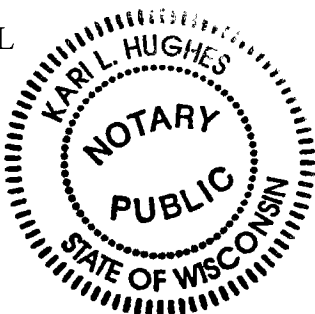
