## ASSIGNMENT

WHEREAS, We, **Elisabeth Schwartz**, a citizen of Austria and a resident of Leopoldstrasse 52/6, 80802 Munchen, Germany; **Michael Waldron**, a citizen of Germany and a resident of Klenzestrasse 7, 80469 Munchen, Germany; and **Sonja Schiefer**, a citizen of Germany and a resident of Hans-Sachsstrasse 13, 80469 Munchen, Germany, have invented certain new and useful improvements in a LEANING RAIL for which we have executed an application for Letters Patent of the United States, of even date herewith; and

AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that we will communicate to the said **Landscape Forms, Inc.**, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said **Landscape Forms, Inc.**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
