## ASSIGNMENT OF INVENTION

WHEREAS, I, Anthony George Wright, 45 Riverside Way, Uxbridge, Middlesex, UB8 2YF, United Kingdom, have invented a certain new and useful improvement in a "Drive and Measurement Circuit For a Photomultiplier" for which an application for Letters Patent in the United States was filed on January 16, 2009.

And I hereby authorize and request the Director of U.S. Patent and Trademark Office to issue said United States Letters

Patent to said ET Enterprises Limited as the assignee of the whole right, title and interest thereto.


