4 II. JUDGMENT

5 THIS MATTER came before the Court on March 6, 2009 on Plaintiff's Motion for
6 Partial Summary Judgment on its claim under the Securities Act of Washington, and on the
7 Defendants' cross-Motion for Partial Summary Judgment and dismissal of the same claim.
8 Plaintiff Norman Enterprises, Inc. appeared personally and through its counsel of record,
9 Hillis Clark Martin & Peterson, P.S. Defendants VOST Management Services, Inc., Gregory
10 and Bonnie Brodd, and James Tyler appeared through their counsel of record, Zeno, Drake &
11 Hively, P.S. In addition, Gregory Brodd appeared in person.

12 The Court considered all briefing filed by the parties with respect to both motions; all
13 supporting declarations and exhibits, including deposition testimony; and all other papers
14 filed in this action. The Court also heard oral argument from counsel. Having considered the
15 foregoing, the Court GRANTED summary judgment in favor of Norman Enterprises with
16 respect to its claim under the Securities Act of Washington. The Court also DENIED the
17 Defendants' cross-motion on the same issue.

18 Consistent with this ruling, the Court now hereby AWARDS and ENTERS Judgment
19 in favor of Plaintiff Norman Enterprises, Inc. and against Defendants VOST Management
20 Services, Inc.; Gregory B. and Bonnie Brodd, and the marital community comprised thereof;
21 and James L. Tyler (collectively, the "Defendants"), jointly and severally, in the following
22 amounts:

23 1. A principal Judgment in the amount of \$500,000.00;

24 2. Pre-judgment interest on the principal Judgment from the date of each of
25 Norman Enterprises's individual stock purchases to the date of this Judgment at the rate of
26 eight percent per annum pursuant to RCW 21.20.430;

27 3. Reasonable attorneys' fees in the amount of \$ 100,839.00 ;

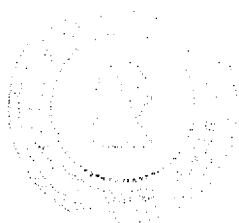
