ASSIGNMENT

ALVEY, INC. DOES ALSO HEREBY authorize and request the Commissioner of Patents and Trademarks to issue that said Letters Patent to **FKI Logistex Inc.**, its successors and assigns, as assignees of the entire right, title, and interest in and to said improvements, for the sole use and behoof of **FKI Logistex Inc.**, and for its successors and assigns, to at least the full ends of the terms for which Letters Patent may be granted;

AND ALVEY, INC. DOES FURTHER grant to FKI Logistex Inc., its successors and assigns, the right to claim for any application for patent for said improvements the full benefit of any international agreement between the United States and any foreign country or countries.
