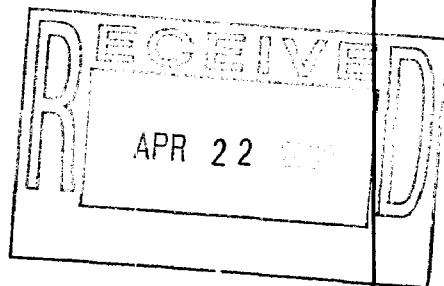

ASSIGNMENT


